## New Signage Will Change Speeds on US-281

Between Monday, December 21 and 24, the Kansas Department of Transportation (KDOT) will begin to upgrade/replace road signage and change posted speed limits in Barton County. The signing enhancement project is scheduled to be completed by early January, depending on delays due to adverse weather conditions.

On the south outskirts of the City of Great Bend US-281 is a two lane rural highway running from south to north. Currently the posted speed limit changes from 65 mph to 55 mph approximately 860 feet southeast of the intersection of SE 20<sup>th</sup> Street; with the speed reducing as traffic approaches the City of Great Bend. The following changes will be implemented:

- Location of the 65 mph / 55 mph break will change to a location of 528 feet north of SE 30<sup>th</sup> Road.
- 55 mph break signage for northbound location will be relocated 1200 feet in advance of the speed limit break.
- Signage will be upgraded in size and utilize fluorescent yellow sheeting.
- Advisory plaques for the northbound and southbound approaches will be upgraded in size and utilize fluorescent yellow sheeting.

Traffic will not be affected by the signing enhancement project. Travel delays are not expected
