KDOT announces approved August bids

The Kansas Department of Transportation announces approved bids for state highway construction and maintenance projects in Kansas. The letting took place Aug. 20 in Topeka.

District One - Northeast

Brown - 7 C-0072-01 - 1.2 miles east and 0.5 mile south of Hamlin, bridge replacement, 0.1 mile, Midwest Construction Company Inc., Holton, Ks, \$424,329.07.

Riley - 18-81 KA-0410-09 - Old K-18/UPRR overpass (near Ogden), remove bridge embankment, 0.1 mile, Ebert Construction Company Inc. & Subsidiary, Wamego, Ks, \$72,952.54.

Johnson - 435-046 KA-3969-01 - I-435 bridge #311 located just west of the Kansas/Missouri State Line (over Indian Creek), bridge repair, Comanche Construction Inc. & Subsidiary, Shawnee Mission, Ks, \$593,936.00.
