## Second I-70 Pavement Repair Project to Begin in Shawnee County

Weather permitting, on **Monday, July 25**, a concrete pavement repair project will begin on a 4-mile stretch of eastbound and westbound I-70 from the Adams Street Interchange to the Kansas Turnpike Toll Plaza in Topeka/Shawnee County. Work will take place primarily during weekend and/or overnight throughout the weekdays.

Varying lane closures will occur throughout the duration of the project with one lane of traffic to remain open in each direction on eastbound and westbound I-70. The lane closures will be in place round the clock (24/7) during the weekend with lane closures beginning at 7:00 p.m. on Friday evening and reopening to all traffic at 6:00 a.m. the following Monday morning. Overnight closures during the weekdays will occur beginning at 7:00 p.m. and will reopen to all traffic at 6:00 a.m. the following morning. The ramps throughout this section of I-70 will be closed one at a time with advance notice. The through ramps will remain open, but will be restricted in width to allow for pavement repair work on half of the ramp at a time. There will be a 14-foot width restriction and a reduced speed limit of 50 mph through the project work zone.

Drivers may encounter delays and are encouraged to use alternate routes, if possible. Updated traffic information for this pavement repair project can be viewed online at: <a href="https://www.ksdot.org/topekametro/laneclose.asp">www.ksdot.org/topekametro/laneclose.asp</a>.

Crews will first remove the damaged areas of concrete and then fill the patched areas back in with new concrete pavement as well as complete joint sealing work as needed. New pavement markings will be applied to the repaired areas.

Iowa Erosion Control, Inc. (Victor, IA) is the primary contractor on this pavement repair project with a total contract cost of \$413,612. The scheduled completion date for the entire project is mid-September 2011.
