# US-24 Bridge Replacement Set to Begin in Shawnee County

## (UPDATES in blue)

Weather permitting, on **Monday, February 27**, a bridge replacement project will begin on the Bourbanis Creek Bridge located west of Rossville in Shawnee County. Work will take place during daylight hours from 7:00 a.m. to 7:00 p.m., Monday through Friday, with some occasional Saturday work.

Beginning **mid-afternoon on Friday, March 9**, eastbound and westbound US-24 over the bridge will be reduced to one lane for both directions of traffic as the bridge will be reconstructed one half at a time. Traffic will be directed across the bridge by traffic signals at either end of the bridge. There will be a posted speed limit of 50 mph through the project work zone. There will be a 13' lane width restriction on the Bourbanis Creek Bridge.

Advance message boards will alert drivers to the lane closure. Drivers should expect major delays during peak travel times and are encouraged to use alternate routes, if possible. Ebert Construction Company is the primary contractor on this bridge replacement project with a total contract cost of \$1.295 million. **The scheduled completion date for the bridge replacement project is late November 2012, weather permitting.**
