US-73/K-7 Resurfacing Project Set to Begin in Leavenworth County

At 8:00 a.m. on Monday, August 27, a resurfacing project will begin on US-73/K-7 (Metropolitan Avenue) from the K-92 (4th Street) intersection to .75-miles west of the 20th Street interchange in Leavenworth (Leavenworth County). (See map below for project location.) Project work includes spray patching of existing pavement, application of a nova chip overlay and permanent pavement markings. The resurfacing project will smooth the road and fill surface defects that can shorten pavement life. Workers will spread a thin layer of asphalt over the pavement then coat it with a layer of rock chips that is pressed into place with heavy rollers. Work will take place during daylight hours, Monday through Friday for the week of August 27-31; then for the remainder of the project (except for pavement marking work), work will take place overnight, 7:00 p.m. to 6:00 a.m., Monday through Friday.

Beginning on **Monday**, **August 27**, eastbound and westbound US-73/K-7 will be reduced to one lane during working hours for the project duration. Crews will begin work with the spray pavement patching the week of August 27-31. Then on **Tuesday**, **September 4 at 7:00 p.m.**, crews will begin the overlay work. Traffic will be reduced to a 12-foot lane width restriction with no speed limit change through the project work zone.

www.ksdot.org/kcmetro/laneclose.asp. Drivers should expect some delays, especially during peak morning/evening rush hours, and are encouraged to use alternate routes, if possible.

The Kansas Department of Transportation urges all motorists to be alert, obey the warning signs, and "Give 'Em a Brake!" when approaching and driving through the project work zone.

Superior Bowen (Kansas City, MO) is the primary contractor on this resurfacing project with a total contract cost of \$537,000. The scheduled completion date for the entire project is early October 2012, weather permitting.
