### **I-35 Weekend Ramp Closures Scheduled for Resurfacing Work in Wyandotte & Johnson Counties**

Weather permitting, beginning on **Friday, June 20 at 7:30 p.m.**, the ramps from southbound I-635 to northbound I-35, southbound I-35 to northbound I-635, and from southbound I-35 to southbound I-635 will close intermittently for pavement repair and resurfacing work. The intermittent ramp closures will take place **beginning on Friday evening at 7:30 p.m. and will reopen to all traffic on Monday morning at 5:00 a.m. for the following weekends: Friday, June 20 - Monday, June 23; Friday, June 27 - Monday, June 30; Friday, July 11 - Monday, July 14; and Friday, July 18 - Monday, July 21.**

These intermittent ramp closures are part of a resurfacing project work that began in early May on both northbound and southbound I-35 from Southwest Boulevard in Wyandotte County to Antioch Road in Johnson County. Repair and resurfacing work is underway for all I-35 mainline lanes and all adjoining entrance and exit ramps

Advance message boards will alert drivers to the intermittent ramp closures. No marked detours will be provided. During the intermittent ramp closures, drivers should expect major delays and are advised to use alternate routes, if possible. Workers will first remove and fill broken pavement sections to smooth the surface and prevent moisture and debris from damaging the pavement. Then they will apply a two-inch layer of asphalt over the pavement which will smooth the road and fill cracks that can shorten pavement life. Once the asphalt overlay is complete, workers will then replace the permanent pavement markings on the roadway surface.

Realm Construction Inc. is the primary contractor with a total contract cost of \$2,708,374. The scheduled completion date for the entire project is late summer 2008.

The Kansas Department of Transportation urges all motorists to be alert, obey the warning signs, and "Give 'Em a Brake!" when approaching and driving through the project work zone.
