### **Southbound US-69 at 103rd Street Lane & Ramp Closures Scheduled this Week in Johnson County (September 18-20)**

Weather permitting, beginning on **Thursday, September 18**, all lanes of southbound US-69 at 103rd Street will close for bridge girder installation for the new southbound US-69 to eastbound I-435 flyover ramp. The ramps from westbound I-435 to southbound US-69, 103rd Street to southbound US-69, and from southbound US-69 to eastbound I-435 will also be closed. All lane and ramp closures will **begin at 9:00 p.m. on Thursday, September 18, and will reopen to all traffic at 5:00 a.m. on Friday, September 19; then will close again at 9:00 p.m. on Friday, September 19 and will reopen to all traffic at 5:00 a.m. on Saturday, September 20.**

Advance message boards will alert drivers to when the closures will occur, even in the event of rain. A marked detour will be provided. Traffic will detour on southbound I-35 to eastbound I-435 to southbound US-69. Drivers should expect delays and are advised to use alternate routes, if possible. Clarkson Construction Company is the primary contractor on this four-year, \$127 million construction project. The scheduled completion date for the entire project is fall 2008.
