# I-70 Resurfacing Project to Resume Work in Shawnee & Wabaunsee Counties

On **Wednesday, March 20**, a resurfacing project will resume on a 13-mile section of I-70 from Valencia Road in Shawnee County to K-30 in Wabaunsee County, including work at the Paxico Rest Area as well. Project work includes spray patching, minor milling and a 4-inch overlay of new asphalt pavement (mainline lanes and shoulders), followed by all new pavement markings. Work will take place during daylight hours (approximately 7:00 a.m. to 6:00 p.m.) with some occasional Saturday work.

Project work began in July 2012 and resurfacing work was completed on the I-70 westbound lanes in late 2012. During the 2013 construction season, crews will complete resurfacing work on the eastbound lanes of I-70.

Beginning on **Wednesday, March 20**, traffic control will be set for the eastbound I-70 left lane closure. Sometime **late afternoon on Wednesday, March 20 or early morning on Thursday, March 21**, the eastbound I-70 left lane will be closed (right lane will remain open) from Valencia Road to K-30 for resurfacing work. Work will first be completed on the eastbound left lane, followed by the eastbound right lane. There will be a posted speed limit of 55 mph and a 14-foot lane width restriction through the project work zone during working hours.

Signage and cones will direct drivers through the project work zone. Drivers should expect some delays during peak travel times. Bettis Asphalt and Construction, Inc. (Topeka, KS) is the primary contractor on this resurfacing project with a total contract cost of \$8.606 million. **The scheduled completion date for the entire resurfacing project is late July 2013, weather permitting.**

The Kansas Department of Transportation urges all motorists to be alert, obey the warning signs, and “Give ‘Em a Brake!” when approaching and driving through the project work zone.
