U.S. 24 Intersection Improvement Project Begins Today in Jefferson County

On **Monday, July 8**, a project will begin to complete intersection improvements at U.S. 24 and Ferguson Road and at U.S. 24 and Linn Road in Perry (Jefferson County). Project work includes the addition of turn lanes and traffic signals at the U.S. 24 and Ferguson Road intersection and widening work at the U.S. 24 and Linn Road intersection. Once all widening work is completed, crews will then mill away 2-inches of the existing asphalt pavement followed by a 2-inch overlay of new asphalt at both intersections. Work will take place during daylight hours, Monday through Friday, with some occasional Saturday work.

Beginning on **Monday, July 8**, crews will set concrete safety barrier on the shoulders of eastbound and westbound U.S. 24 at Ferguson Road for the roadway widening work. Traffic will be directed through the project work zone via concrete barrier, signage and cones. There will be an 11-foot lane width restriction both directions on U.S. 24 throughout the project duration. Eastbound and westbound U.S. 24 traffic should expect delays during peak commute times and should allow extra travel time for their daily commutes.

Project work will include potential closures of Ferguson Road, Elm Street, and Cedar Street in Perry. Marked detours will be provided and advance separate notification will be sent for these roadway closures.

The Kansas Department of Transportation urges all motorists to be alert, obey the warning signs, and “Give ‘Em a Brake!” when approaching and driving through the project work zone.

Hamm Inc. (Topeka, KS) is the primary contractor on this intersection improvement project with a total contract cost of \$709,182. **The scheduled completion date for the overall project is early September 2013, weather permitting.**
