## **UPDATE!** US-24 Reconstruction Project Begins in Jefferson County

On **Monday**, **June 18**, a pavement reconstruction project will begin on a 5.3-mile section of US-24 from **just west of the Muddy Creek bridge in Grantville to just east of the K-237 junction in Jefferson County**. Project work includes removal and replacement of pavement, shoulder work, and the addition of a right turn lane at Clark Road. Work will take place during daylight hours Monday through Friday, with some occasional Saturday work.

The week of **Monday-Friday**, **June 18-22**, eastbound and westbound US-24 traffic will have varying lane closures in preparation for the closure of the eastbound US-24 lanes on Monday, June 25. Beginning on **Monday**, **June 25**, the eastbound lanes of US-24 will be closed and eastbound and westbound traffic will be carried on the westbound lanes (side by side) with one lane in each direction. Eastbound US-24 traffic will be carried to and from the westbound lanes via a crossover installed just east of Barton Road in Grantville. Traffic will be directed through the project work zone via signage and cones. There will be a posted speed limit of 55 mph and a 12-foot lane width restriction through the project work zone during working hours.

Ideker, Inc. (St. Joseph, MO) is the primary contractor on this pavement reconstruction project with a total contract cost of \$8.157 million. **The scheduled completion date for the pavement reconstruction project is early July 2012, weather permitting.**
