KDOT to host series of virtual 69Express noise abatement meetings

TOPEKA – During the week of Jan. 24, the Kansas Department of Transportation (KDOT), the Kansas Turnpike Authority (KTA) and the City of Overland Park will hold a series of six virtual meetings for members of the public to learn and ask questions about potential noise wall locations that could help address future traffic noise impacts as part of the U.S. 69 Expansion Project, known as 69Express.

Individuals who own or reside in benefitted receptors – locations that may experience traffic noise volumes at or above the 66 dB threshold and would receive at least a 5 dB reduction in noise levels through construction of a noise wall – have been notified directly about the availability of the upcoming virtual meetings. Benefitted receptors are eligible to vote on whether KDOT should proceed with building noise walls near their locations. Noise walls will be constructed only if 70% of the eligible votes are favorable.

Four of the online meetings will focus on location-specific findings from the 69Express noise study. Two additional general sessions are available for those who are unable to attend the meeting designated for their area. Meetings will be held:
